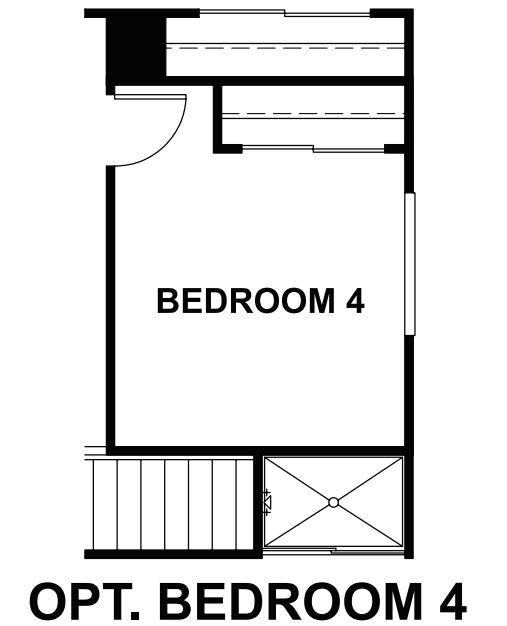
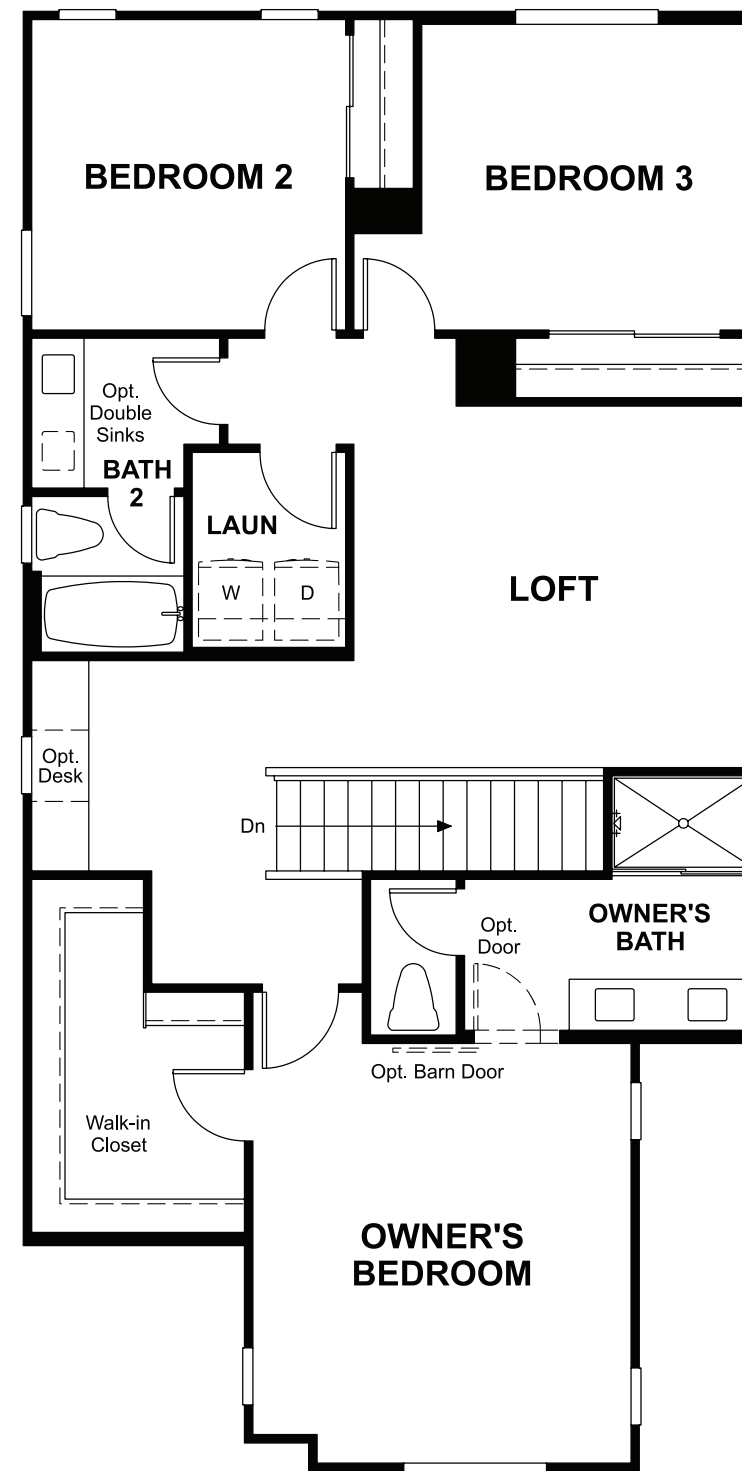


ELEVATION B
